The foundation board turned down the countys request due to the need for structural repairs. Those repairs are now made so we can offer the building as a shelter. Events that occur at the Cuban Club drive room nights and bring day visitors that benefit our area through sales tax payments and parking fees. The four-story 1917-era neo-classical building with Beaux-Arts Revival elements is an imposing architectural jewel individually listed on the National Register of Historic Places. Estimates of the record-breaking increase in tourism in Ybor City and Tampa are also made by the Ybor City Development Corporation and Chamber of Commerce.
